#### 1. Celebration of STARS Platinum!

- a. CSU is the first STARS Platinum University.
- b. CSU's STARS score is 85.29. (85 is cut off for Platinum)
- c. An anonymous user has challenged a few items in CSU's STARS report and AASHE has come to CSU's defense.
- d. The news of Platinum has been successful in social media outlets.
- e. Faculty have shared that they are challenged about how to incorporate the STARS model into their courses.
- f. Pending approval of PSC's FY16 Budget Request to Amy Parsons, there are options to engage faculty in the incorporation of sustainability into courses.
- g. CSU representatives have been invited to the 2015 AASHE Conference to speak about the challenges of submitting a Platinum-level report.
- h. The STARS score is valid for three years from submission.
- i. STARS will release a new version of the system in the future.

#### 2. CSU is #12 on Princeton Review's Top 50 Green Colleges list

- a. CSU has been ranked #12 on the Princeton Review's Top 50 Green Colleges list, which is the first time CSU has ranked so high on their list.
- b. STARS Platinum report will be used as a base for future submissions to Princeton Review.

#### 3. Green Ribbon Schools Update

- a. CSU has been selected as one of 9 universities as the inaugural Green Ribbon Schools in Higher Education.
- b. There will be an award acceptance ceremony in Washington D.C. this summer.
- c. The award can never be won again.

## 7. Updates from Members

**Aaron Fodge** – Aaron is working on a grant to provide two more electric vehicle charging stations in the Lake Street Parking Garage. The Research Drive Parking Lot will be EV ready, meaning charging stations can be easily installed. To increase EV turnover, Aaron is also working to develop a policy about how long EVs can stay charging.

**Jake Drenth** – The Tent Sale is scheduled for June 20<sup>th</sup> and 21<sup>st</sup> at Surplus Property. Volunteers receive coupons to use at the sale. Jake is looking for temporary staff for the sale. Some of the profit from the sale will go towards the Eco Leaders program.

**Brian Dunbar** – The Institute for the Built Environment has submitted a grant application for Fort Collins to be recognized as an Eco-District. An Eco-District can be a city or a neighborhood and is evaluated on 6 performance areas. This effort is being conducted in tandem with the City of Fort Collins. Brian will share more details as the process moves along.

**Tonie Miyamoto** – Tonie and Carol will soon meet with Amy Parsons to discuss the outcome of the PSC's FY16 funding request. Part of the request will go towards funding a PhD. fellow to complete future STARS applications.
