## Spring 2015 Advising Codes

### What are advising codes?

These are 6-digit codes assigned to students by departmental request based on criteria such as major and class level or probation status. Advising codes for fall 2015 registration are assigned on February 10, 2015. **Let us know soon if your department needs to make a change!** Students must enter the advising code during the Registration Ready process (available March 16) before registering for courses.

### How do students get their advising codes?

Advisors provide students with codes and can find advising codes one of two ways: by looking up a student in ARIESweb and checking the advising code in the Current Student Summary on the top left of the screen or by using the Advising Codes link under Staff Tools in ARIESweb to grab a list of all the students in the department that have an advising code.

### Fun fact about advising codes:

Most advising codes are assigned to Undergraduate students, but a few Graduate programs do request advising codes. All new students have advising codes.

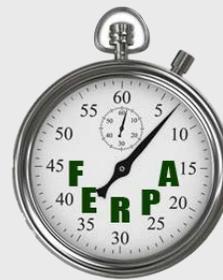

**FERPA Minute** **Q**: What does a full confidentiality hold on a student's record mean, and what are the consequences for the student?

**A**: No one at the University can discuss a student's record unless the student is there, in person, with a valid photo ID. The consequences are many: students cannot call to remove holds, talk to advisors, ask about their degree progress, or make any transactions over the phone. Students' degrees cannot be verified by employers or background check services. We recommend students carefully consider the implications of placing such a hold, particularly if they plan to move out of state. Another option for ensuring privacy without placing a full confidentiality hold is having the student select "Change My Directory Preferences" under the "Manage My Student Records" link in RAMweb and removing their address and/or phone number to keep out of the public online directory.
